Gas delivered hereunder will be separately metered and shall not be used interchangeably with gas supplied under any other rate schedule.

2. Rate Per Month:

3. Rate per Ccf:

Seasonal rate filed annually by April 1, for approval by the Public Utilities Regulatory Authority (the "Authority"). The rate so established shall be for the May through September seasonal period.

4. Minimum Rate:

Unless authorized by the Authority as in the public interest, the average price of gas sold, excluding the service charge, by the Company to any customer under this rate schedule shall not be less than the current cost of gas per Ccf as estimated by the Company plus \$.005/Ccf divided by 0.95, or other factor reflecting the currently applicable taxes.

5. Maximum Rate:

The average price of gas sold, excluding the service charge, by the Company to any customer under this rate schedule shall not exceed for the billing period the rate per Ccf of the customer's applicable firm rate.
